We had the honor of having Illustrious Sir, Ed Stolze, High Priest and Profit, do a presentation on the Imperial Shrine Vision for 2035. The food and dessert were fantastic. The Orleans did an excellent job on all the preparations for the event. I would like to thank Phil Pupanek for all his hard work and being the Master of Ceremonies for the event. Also, the Legion of Honor for doing the Presentation of the Colors.

I was so proud of all the Nobles who participated in the 4th of July parades in Boulder City and Pahrump. It was good to see the pictures of so many Shriners out supporting our Shrine. If you have any pictures of the parades that were not already sent to the Shrine or me, please send them to us as we want to include them in the Zelzah News.

As you all know, Zelzah Shrine is dark in July. However, we did attend the Shriner's International Convention in Houston, Texas the first week of July. The Chief Rabban, Alan Wise, Assistant Rabban, David Bechtel, and I were the officers that attended from Zelzah Shrine. Alan Wise and I voted on all the Iowa Corporation (Shrine Business) and Colorado Corporation (Hospital Business) items. There were several Past Potentate's from Zelzah's Shrine at the convention to represent our Shrine and who voted on the Colorado Corporation items. Some of the votes that directly concern you will be discussed at the August Stated Meeting. The main vote concerning the increase in per capita was rejected. However, the vote on requiring a line officer to attend either the Oriental Guide or Assistant Rabban class to be Potentate did pass and the effective date is November 1, 2022.

In August, we will be having our Taco Tuesday on August 17, 2021, at the Shrine. Also, the Past Potentate's will be putting on their world-renowned Fish Fry at the Zelzah Shrine on Saturday, August 28, 2021. You do not want to miss these events as they do an excellent job. Be sure to invite your family, friends, and brother masons from your Lodge and their family and friends.

Even though the Shrine is dark, we are working on several projects to improve your Shrine. We want you to be proud of the Shrine and feel comfortable to invite your friends and family to the Shrine. Currently, we are proceeding with increasing the lighting and changing the existing lighting package to brighter lights so the parking lot and sidewalk will be much brighter in the evening, changing security companies to Sonitrol and adding security cameras to the facility, repairing, and resurfacing the sidewalk in front of the entry way into the businesses, replacing broken parking lot bumpers and restriping the parking lot. In the third quarter of this year, we will be resurfacing the area in the back of the building and moving the fencing to improve security behind the building.

I am sure you have heard the Corona Virus is on an uptrend, so I am recommending, we wear masks. If you have not been vaccinated, please wear the mask as your Shrine brothers and their family's safety is important to all of us. Please be safe and I hope to see you at our next Stated meeting in August.

Recorder Ramblings**Mike Reinhardt**

I want to share my Delta Variant of Covid-19 experience with you because I fear that some of you may not have yet been vaccinated. This mutant virus is not a joke, it does not care if you have been vaccinated or not! It is highly contagious, and far more serious to deal with.

I went to Urgent Care with bronchitis and was given a Covid test as they do with all patients. You could have knocked me over with a feather when I got the news of the positive test. Medications, an inhaler, and cough medications helped. Other long-term effects on the heart and other organs has been experienced by some victims of this virus.

Thoughts from the Chief Rabban**Alan Wise**

Nobles of Zelzah Shrine:

This month I want to pass on highlights and information from the Imperial Session held in Houston, TX as well as pass on some protocol for Shriners wearing a fez.

The Imperial Session was held 4 – 8 July 2021 in Houston, TX and the following are the results of the balloting on the resolutions:

Resolution 1: Dealt with making changes to Article 1 (*General Provisions*) and Article 11 (*Budget and Revenues*) which would have authorized Shriners International to accept a petition for membership from any candidate that met the prerequisite for membership as provided in SS 323.3. **Resolution FAILED.**

Resolution 2: Article 4 *Sessions* - This resolution added the words “*or Declared Disaster*” to Article 4 *Sessions* and would allow the Board of Directors to consider cancelling an annual Imperial Session of Shriners International. **Resolution PASSED.**

Resolution 3: Article 5 *Message and Per Diem* - This dealt with changing the procedure for distribution of the per diem and mileage reimbursement for representatives entitled to such payments. Change would allow for payment by mail or electronic funds transfer within 10 days of the close of the Imperial Session. **Resolution PASSED.**

Resolution 4: Article 7 *Board of Directors* – Approval of this resolution would allow for the Board of Directors to conduct not only in-person meetings but also internet or telephonic meeting service provided appropriate notice and necessary means to participate is given. **Resolution PASSED.**

Resolution 5: Article 8 *Committees* – This resolution dealt with clarified when meetings occur and provided for conducting these meeting in-person, via internet or telephonically. **Resolution Passed.**

Resolution 6: Article 11 *Budget and Revenues* – This resolution if passed would raise the per capita tax from \$30 to \$50 for each member of a temple. **Resolution FAILED.**

Resolution 7: Article 23 *Temple Membership* – This resolution would amend the Article to allow a temple to accept a petition from a Master Mason or from a candidate of good character provide the person of good character met the age requirement for Masonic membership in the Masonic jurisdiction of the temple and is thoroughly investigated by the temple. **Resolution FAILED.**

Resolution 8: Article 25 *Officers: Their Election or Appointment* – This resolution would require a qualification for serving as a temple Potentate would require serving at least one term as either Chief Rabban or Assistant Rabban and attendance of either the Oriental Guide or Assistant Rabban training seminar as sponsored by Shriners International Education Foundation. This resolution is approved would become effective November 1, 2022. **Resolution Passed and will go into effect November 1, 2022.**

Resolution 9: Article 25 *Officers: Their Election or Appointment* – Passing of this resolution would require Elected officers of a temple divan to have their dues paid in full and up to date for the next calendar year and must be in good standing as a Master Mason to be qualified to stand for election. **Resolution FAILED.**

Resolution 10: Article 25 *Officers: Their Election or Appointment* – Approval of this resolution would change the time notice requirement to the Imperial Recorder’s office of an appointment to fill a vacancy in the office of an elected Representative. There was a proposed amendment to this resolution which was approved. As amended the **Resolution PASSED.**

Resolution 11: Article 29 *Dispensation and Charter for New Temple* – This resolution sought to extend the exceptions to the required signatures and effect on other temples for a new temple to obtain a dispensation would now apply within the Republic of Mexico. **Resolution FAILED.**

Resolution 12: Article 35 *Prohibited Practices* – This resolution sought to make the use of the Logo for Shriners Hospitals for Children in any fundraising activity without the written consent of the Imperial Potentate and the Chairman of the Board of Trustees of the Hospitals would be a prohibit practice. **Resolution PASSED.**

Resolution 13: Article 35 *Prohibited Practices* – Passage of this resolution would allow Shriners International to use the lists of members furnished by the temples to disseminate information about, solicit gifts, contributions and bequests to and solicit donation for fundraisers on behalf of Shriners International Education Foundation on such terms and conditions as directed by resolution adopted by the board of directors of Shriners International. **Resolution PASSED.**

Resolution 14: Article 36 *Temple Units* – This resolution sought to allow female guest to participate in marching units or clown groups if distinguished from Nobles in dress. **Resolution FAILED.**

Resolution 15: Article 45 Alabama - This resolution sought to change the jurisdiction in the County of Sumter, Alabama from Abba Shriners to Zamora Shriners. **Resolution PASSED.**

Resolution 16: Articles 47, 49 and 98 - **Resolution WITHDRAWN.**

Resolution 17: Articles 53, 102 and 103: This amendment would voluntarily change the jurisdiction in South American between Almas Shriners, Hikmat Shriners, Amal Shriners and Bolivia Shriners. **Resolution PASSED.**

Resolution 18: Articles 98 and 54 - **Resolution WITHDRAWN.**

Resolution 19: Resolution requested authorization for Anezeh Shriners to withdraw from the Western Shrine Association. **Resolution PASSED.**

Resolution 20: Resolution requested permission for Abou Saad Shriners to withdraw from the Southeastern Shrine Association. **Resolution PASSED.**

Resolution 21: Requested authorization for relocation of Amara Shriners. **Resolution Passed.**

Resolution 22: Request authorization to form the "*International Association of Shrine Taproom.*" **Resolution PASSED.**

Resolution 23: Petition received from Nobles and Master Masons in the country of Brazil for dispensation to open a new temple titled Salah Shriners in Florianopolis, Sant Catarina, Brazil. **Resolution PASSED.**

Resolution 24: Petition received from Nobles and Master Masons in the country of Mexico for dispensation to open a new temple titled Al Atfal Shriners in Culiacan, Sinaloa, Mexico. **Resolution PASSED.**

As a side note, when attending an Imperial Session do not come into your hotel room and let the door slam if your wife is asleep. Otherwise, she may raise can with your fellow Nobles who were out with you that evening!!! ; /)

The following protocol when wearing your fez is provided to new Nobles to help you understand the protocol and as a refresher for other Nobles.

1. During the invocation all Nobles will remove their fez and place over right hand and hold over heart, emblem facing forward.
2. During the Pledge of Allegiance all Nobles wearing a fez will present right hand salute and others place the right hand over their heart.
3. Wear your fez at all Temple and office functions unless otherwise directed by the Potentate. When the Potentate wears his, you wear yours. When he takes his fez off, you may uncover.
4. Nobles stand when the Potentate makes his entrance or is introduced.
5. The Tassel is worn on the left side of the fez. Not more than two pins or clasps, without supplemental embellishments, may be used to secure the tassel in place.
6. Wearing a Titled Fez. A Potentate's appointment to a titled position is for the calendar year he is Potentate. A Noble receiving an appointment and who is authorized to wear a Titled Fez, may wear the title only during that Potentate's year unless the Noble is reappointed by the next Potentate.
7. The Salaam: A Noble addressing the Potentate while he is presiding in the East should always give the salaam. The Potentate will respond with the sign of the Order. The salaam is always given by the Potentate and members of the Divan when receiving the Imperial Potentate, Imperial Officers, and Past Imperial Potentates. The Imperial Potentate as well as the Imperial Officers and Past Imperial Potentates do not Salaam in return but give the sign of the Order.

**High Priest & Prophet****Mike Clark**

Brother Nobles, this is an excerpt from the History of the Ancient Arabic Order Nobles of the Mystic Shrine.

The emblem of Shriners is the Crescent that was adopted as the Jewel of the Order. Though any materials could be used in forming the Crescent, the most valuable were the claws of a Royal Bengal Tiger, united at their base in a gold setting. In the center was a head of a sphinx, and on the back were a pyramid, urn and star. The jewel bore the Arabic Motto "Kuwat wa Ghadab" which means "strength and Fury." Today the Shrine emblem includes a scimitar from which the crescent hangs and a five pointed star beneath the head of the sphinx.
